CAA Programs:

COMMUNITY BUILDING - CAA's community building efforts include direct services for
individuals and families, grassroots organizing and leadership development, community
forums that promote civic engagement, and media outreach to engage and educate the
public on critical issues.

In 2011, our low-income, limited-English proficient constituents continued to
struggle through the economic recession. With fewer employers hiring and demanding
higher skills from job seekers, CAA increased our employment counseling, job
readiness training, and placement in the hospitality and construction sectors to work
closely with nearly 200 clients. To complement these efforts, we also helped lead a
coalition of service providers to better coordinate the creation and identification
of sustainable jobs, trainings, resources, and other opportunities to support the
economic independence of immigrant families.

At our headquarters in Chinatown, staff fielded over a thousand walk-in and telephone
inquiries from community members needing information and referrals on English as a
Second Language and vocational classes, seeking advocacy against workplace
discrimination, and wanting assistance with housing, immigration, legal, and other
public services.

In its seventh year, our leadership development program, CAA Parent Advocates,
successfully graduated twenty immigrant parents from our training series. These
parents joined 100 other parents who have participated in the program that was
formerly known as the Visitation Valley Parents Association to become stronger

advocates on behalf of their children and public schools. Through their peer organizing, grassroots campaigns, and service on school committees, they fought for school and social policies that better integrate the participation of limited-English proficient (LEP) immigrants.

The November 2011 general election in San Francisco provided a unique opportunity to introduce many new constituents to local democratic processes and policymakers. At our well-attended membership meeting in March and a full-house bilingual candidates forum in September, community members were able to hear directly from Mayoral candidates on several issues of concern. We also partnered with the San Francisco Department of Elections to educate LEP citizens on their voting rights and the City's ranked-choice voting process.

Our working relationship with media outlets, especially those serving the Chinese language community, remained strong. Dozens of CAA events, press conferences, and campaigns were covered widely on issues ranging from immigration, local hiring policies, politics, and redistricting.

IMMIGRANT RIGHTS - CAA strives to create a society that fully embraces and values its immigrant population. We provide and advocate for social services to protect immigrant rights, educate community members on changes to immigration laws, and ensure immigrants are aware of community resources available to them.

Decades after the idea was born, and three years after the critical vote to advance the project, CAA remained a leader in efforts to open a permanent City College campus facility in San Francisco Chinatown by Fall 2012. In coordination with Friends of

Educational Opportunities in Chinatown (FEOC), we held press conferences and community meetings to apprise the public on progress, and later rallied the community to raise \$800,000 to support furniture and equipment not covered by State funds.

We also worked to increase the number of construction employment opportunities that were accessible to local residents, including those with limited-English proficiency.

By monitoring local hiring and chairing the local hiring oversight committee, CAA collaborated with contractors, architects, labor unions, and the college administration to steadily increase the local hiring percentages throughout the construction of the campus project.

In addition to providing advocacy to create more positive opportunities for newcomers, CAA assisted immigrants contending with our nation's broken immigration system. As a founding member of the San Francisco Immigrant Legal and Education Network (SFILEN), CAA educated community members on changing immigration rules, helped residents check their status and apply for visas, and conducted know-your-rights workshops such as preventing immigration fraud. CAA also joined efforts against misguided programs such as Secure Communities and e-Verify and participated in the annual Immigrant Family Day at City Hall.

The broad array of challenges facing immigrants were made clear by one case that came to CAA in 2011: a bilingual speech and language pathologist with the San Francisco Unified School District lost her job primarily because the school district managed her visa process poorly. Though CAA worked with school officials to craft a policy to prevent this situation from happening to other employees, in this instance our community lost a valuable resource who had successfully worked with San Francisco

families for over eight years.

LANGUAGE DIVERSITY - CAA remained persistent in its advocacy for a San Francisco that embraces the participation of all residents in decisions that affect their lives, regardless of language ability.

At the technical level of local government, we reviewed and analyzed the annual "Language Matters: Language Access Ordinance Annual Compliance Summary Report" published by the City and helped share our findings and perspectives with elected officials, department heads, community partners, and the public to urge additional progress. One aspect of this effort has been to compile and present the impact that the lack of language access can have in more human terms. These stories often come to us as a result of our direct contact with those most affected.

In the community we conducted technical assistance and outreach on language access rights; distributed materials and led workshops on federal, state, and local language access requirements; and hosted bi-monthly immigration workshops that included language access information. These efforts were offered in Cantonese throughout the City including Chinatown, the Mission, Visitacion Valley, Sunset, Richmond, and Tenderloin.

CAA also served as a language access resource for a broader set of stakeholders. For example, CAA served on the BART Limited English Proficient Advisory Committee, and worked with Chinatown Community Development Center and their efforts to achieve a more multi-lingual Municipal Transportation Agency. We advocated for a limited-English proficient patient at UCSF hospital, and supported the Arab Resource

and Organizing Center with local Arabic language resources.

In addition, the multilingual Community Ambassadors Program pilot that CAA helped develop in 2010 was extended and expanded to include the mid-Market and Tenderloin neighborhoods. Initially offered as one of several responses to interracial crime in the Southeast Sector that was exacerbated by the lack of language access in City public safety agencies, the multi-lingual Ambassadors provide a public presence and assist residents in busy public transit areas with safety tips and other information in eight languages.

RACIAL JUSTICE - CAA combats multiple forms and manifestations of racism and racial hierarchy. This includes speaking out against harmful stereotypes, identifying and addressing discrimination, and advancing policies that promote racial and ethnic inclusion and equity.

To address employment discrimination that has long plagued low-income, women, racial minority, and other disadvantaged communities, CAA continued to support legislation and initiatives that make employment on City-funded construction projects more diverse. In 2011, CAA and allies began monitoring implementation of San Francisco's local hiring ordinance -- legislation that required more than a year of organizing across communities and engagement with labor unions, contractors, environmentalists, elected officials, and community advocates.

Diversity in our judicial system also remains a priority for CAA. In 2011 we joined with many organizations and individuals to successfully advocate for the appointment of Judge Edward Chen to the U.S. District Court. Shortly after, we campaigned with

allies for the appointment of Goodwin Liu to the U.S. Court of Appeals. Senate Republicans blocked his confirmation, but we were pleased to support his eventual appointment to the California Supreme Court.

Following efforts to ensure all communities were counted for electoral representation in Census 2010, we shifted our work in this area to the equal allocation of voting power. CAA Director of Community Initiatives Jenny Lam served as vice-chair of the the San Francisco Redistricting Task Force and helped oversee a process to make sure that underserved communities had their voices heard and voting rights protected.

API EQUALITY - NORTHERN CALIFORNIA:

At API Equality, renewed attention was focused on developing culturally-grounded avenues to win hearts and minds for Lesbian, Gay, Bisexual, Transgender, and Queer/Questioning (LGBTQ) acceptance in Asian American and Pacific Islander communities. This included groundbreaking in-depth, formal, and empirical research in analyzing API attitudes toward LGBTQ individuals and recommendations for effective media messaging that are now being implemented.

API Equality also helped increase queer API visibility by developing a speakers bureau to speak at conferences and by providing technical assistance to four queer API groups with services that included trainings and consultations.

API Equality also represented queer API perspectives in the broader LGBTQ community through service on the Let California Ring Executive Committee, conversations with Somos Familia to share program best practices, support for the Progressive POC Collective, participation in the Queer Women of Color Media Arts Project training

program, and co-sponsorship of Equality California's Back to the Ballot forum.

One special highlight of the year was when over 100 LGBTQ Asian American and Pacific Islanders and allies performed in a flash mob in San Francisco Chinatown bearing the message of "Love, Equality, and Acceptance." Coupled with earned media efforts in the Chinese language press, the event brought visibility to over 66,000 queer APIs in California.

In Sacramento, CAA's statewide legislative efforts continued in collaboration with the Asian Law Caucus and the Asian Pacific American Legal Center. Thirty statewide bills impacting civil and immigrant rights were prioritized and tracked through the legislative process. Our collective work focused on policy analysis for stakeholders, organized support or opposition, testimony for legislative committees, and advocacy and education with legislators and their staff. Highlights of this work included helping to defeat a bill that would have negatively impacted the ability of low-income persons and immigrants to participate in elections, and championing major legislation (AB 1088) to better collect and disaggregate data on Asian Americans, Native Hawaiians, and Pacific Islanders. The success of AB 1088 can be attributed in part to the bill's author, Assembly member Mike Eng, and to over 1,200 individuals and 100 organizations who signed petitions and submitted letters of support.

With the Asian Law Caucus and the Asian Pacific American Legal Center, our Sacramento office also helped coordinate the annual API Policy Summit Day that convenes advocates and policymakers from across California for united advocacy and

Modeled after the success of our unique relationship with API Equality - Northern California, we are now working with four additional groups: the Alliance of South Asians Taking Action, Asian Prisoner Support Committee, Hyphen magazine, and the Network on Religion and Justice.

Together with CAA and API Equality, these groups will share administrative, campaign, and movement building resources while exploring and deepening the connections that our collective members, volunteers, and staff have with one another.
