MARSH CREEK 5 AND 6 (SIZE 7.4 AND 5.74 ACRES) - LOCATION MARSH CREEK - MORGAN TERRITORY AREA. THE PROPERTIES ARE LOCATED EAST OF CLAYTON, DOWNSTREAM FROM TWO OF OUR OTHER PROPERTIES. MARSH CREEK 5 AND 6 ARE ESPECIALLY BIOLOGICALLY DIVERSE, PARTLY BECAUSE THEY ARE RARE VOLCANIC DOMES WITH HIGH SILICA CONTENT. THOMAS HOME RANCH (SIZE 145.5 ACRES) - LOCATION KIRKER CREEK, PITTSBURG AREA. THE RANCH, HOMESTEADED BY THE THOMAS FAMILY IN 1869, IS LOCATED AT THE INTERSECTION OF KIRKER PASS AND NORTONVILLE ROADS, JUST SOUTH OF PITTSBURG. EAST BAY REGIONAL PARK DISTRICT WAS INTERESTED BUT UNABLE TO BUY THE PROPERTY. SAVE MOUNT DIABLO WAS ABLE TO PURCHASE THE PROPERTY AT AN ESTATE COURT AUCTION, OUTBIDDING A POTENTIAL DEVELOPER, TO PRESERVE THE THOMAS HOME RANCH FOR FUTURE PARK ADDITION AND PUBLIC ACCESS. MARSH CREEK 7 (SIZE 7.6 ACRES) - LOCATION MARSH CREEK - MORGAN TERRITORY AREA. DESPITE ITS SEEMINGLY SMALLER SIZE, MARSH CREEK 7 MORE THAN DOUBLES THE SECTION OF CREEK PREVIOUSLY PROTECTED AT THE ADJACENT MARSH CREEK 1 PROPERTY. IN ADDITION TO MARSH CREEK, THE PROPERTY IS PART OF ANOTHER IMPORTANT WILDLIFE CORRIDOR BETWEEN CLAYTON RANCH AND BLACK DIAMOND TO ROUND VALLEY.
