Our signature on-line publication, Colorlines.com, publishes daily news content as well as deep investigative features that successfully engages readers on a daily basis. In 2011, we doubled the number unique visitors to Colorlines.com having reached over 2.5 million readers. We also tracked over 1,000 media hits for ARC and Colorlines in 2011. Key areas of coverage over the past two years have included immigration, gender and sexuality, health care, media policy, and other related issues.**4b** (Code: RJLAN) (Expenses \$ 582,049. including grants of \$ -) (Revenue \$ 249,856.)The Racial Justice Leadership Institute (RJLAN) combines leadership development and education with strategic planning that focuses on advancing racial justice. In 2011, the RJLAN offered new platforms for training delivery by offering a unique series of webinars to reach new audiences. The RJLAN coordinates ARC's national conference, called Facing Race, to be held in Baltimore, MD in 2012. The conference draws more than 1000 policy makers, activists, thinkers, educators, writers, and artists from across the country. In 2011, the RJLAN spearheaded the Drop the I-Word Campaign (DTIW), a national call on individuals and media outlets to stop the use of the word, "illegal" to describe people. Thus far, the campaign has garnered pledges to "Drop the I-Word" from nearly 13,000 individuals and 21 media outlets, and support from over 30 organizational endorsers.**4c** (Code: See Schedule O) (Expenses \$ 390,262. including grants of \$ -) (Revenue \$ -)See Schedule O**4d** Other program services (Describe in Schedule O.) Research: ARC research focuses on the continued significance of race and ethnicity to social and economic outcomes in our society. Focusing largely on institutional and structural racism as opposed to personal prejudice, ARC's research seeks to reveal the hidden or ignored race effects of public policies and practices both within and across interconnected sectors such as education, immigration, criminal justice, employment and health. In 2011, ARC released four groundbreaking reports:

1) Better Together, an assessment of the current positioning of LGBT issues and constituencies within the Racial Justice movement; 2) Shattered Families, which explores the extent to which children in foster care are prevented from uniting with their detained or deported parents and the failures of the child welfare system and ICE to adequately work to reunify these families; 3) Color of Food, a report that stressed the need for the Food Justice Movement to include workers of color, and; 4) Don't Call Them Post-Racial, the results of research designed to determine the political beliefs of the millennial generation, specifically their views around race and racial equity.

Sponsored Projects: In keeping with ARC's mission, the Fiscal Sponsorship program provides assistance for new projects through infrastructure support for research, organizing or educational purposes.
