Farm to School - CAFF is leading the Farm to School effort in California, with active Farm to School programs in the Bay Area, South Bay, Central Coast, Humboldt and Silicon Valley regions. The program experienced major growth this past year as we worked to address growing concerns over children's health, economic viability of farmers, and the environment and our food system. The Know Your Farmer program that brings farmers into the classroom and school children out on farm field trips reached 5,000 students in the 2010-2011 school year. CAFF's Harvest of the Month Tasting Kit program grew to 5 counties this year, providing 350 classrooms with farm fresh produce and curriculum, empowering classroom teachers to take the lead on food and farming lessons in the classroom for over 12,600 students. Local Food Systems - A major accomplishment in 2011 for the Local Food Systems team was the completion of our USDA Rural Business Development funded "Hub" feasibility study and the collaboration with Buckelew programs to establish a food "hub" for California's North Coast counties. This project will provide a new distribution point for farmers and a new source for retailers and food service operator that want to support local farmers. Another component of this project includes the powerful Buy Fresh Buy Local public education campaign that is a major contributor to keeping local dollars circulating in the local community.

4c (Code _____) (Expenses \$ 78,070. including grants of \$ _____) (Revenue \$ _____)

Policy - CAFF's policy program promotes sustainable agriculture and local food systems in California through education, lobbying, and on-the-ground outreach to farmers. In 2011, CAFF continued its work on water stewardship in agriculture through its participation in the California Roundtable on Water and Food Supply, the Community Water Dialogue of the Pajaro Valley, and by promoting dry farming techniques in wine grape production. CAFF also participated in state-sponsored task forces on direct marketing and small-scale raw milk marketing, including potential regulation of Community Supported Agriculture. Finally, CAFF continued its multi-year work on food safety by launching an outreach program to assist family farmers with on-farm food safety plans.

Cafeteria Program builds relationships between farmers and K-12 food service programs to facilitate the use of more local food in school cafeterias. Our work in this area grew leaps and bounds in 2011, as we worked with five school districts to build community support for farm to school programs, determine the best products to introduce into the schools, and facilitate purchasing with local farmers or with distributors. At the state level, CAFF co-led the California Farm to School Taskforce, a statewide body that brings together a diverse network of stakeholders that promote and create opportunities to connect schools with their local farms in the classroom, in the cafeteria, and in the community. The taskforce has been leading the charge to break down policy barriers that inhibit farm to school while advocating for dedicated positions within state agencies to support farmers as they sell to schools. By using the combined three strategies of direct education, policy and farm to cafeteria with school districts over the long term, Farm to School programs have the ability to truly reform school lunch, decrease childhood obesity rates, and provide viable markets for local growers.

promoted by the California Climate and Agriculture Network (CALCAN), a coalition that CAFF helped to found: SB 489 (Wolk), which extended the net metering program to all renewable energy sources; and SB 618 (Wolk), which created an alternative Williamson Act program for converting marginal farm land to solar power generation. We also supported AB 395 (Huffman), a bill that requires the mapping of groundwater recharge areas and their consideration by local land use planning authorities.

CAFF is represented in Washington, DC, by the National Sustainable Agriculture Coalition (NSAC), and CAFF's active involvement in lobbying in 2011 revolved around rulemaking by the Food and Drug Administration for the Food Safety Modernization Act, as well as the Senate Agriculture Committee's initial draft Farm Bill.
