AMENDED AND RESTATED BYLAWS

OF

BOYS & GIRLS CLUBS OF LAS VEGAS FOUNDATION, INC. a Nevada nonprofit corporation

ARTICLE I

FOUNDATION'S ARTICLES AND OFFICE

Section 1. References to Articles. Any reference in these bylaws (the "**Bylaws**") made to the Articles of Incorporation (the "**Articles**") of Boys & Girls Clubs of Las Vegas Foundation, Inc. (the "**Foundation**") will be deemed to refer to its articles of incorporation and all amendments thereto at any given time on file with the Nevada Secretary of State, together with any and all certificates filed by the Foundation with the Nevada Secretary of State pursuant to applicable law.

Section 2. Principal Office. The Foundation may have offices at such places, in or outside the state of Nevada, as the Board of Trustees of the Foundation ("**Board of Trustees**") may, from time to time, determine.

Section 3. Corporate Seal. If the Board of Trustees resolves to acquire a corporate seal, the seal shall be in a form approved by the Board of Trustees, but in any event must contain the name of the Foundation and the words "Nevada" and "Seal" as elements. Unless required by law, the use of a corporate seal shall not be required for use on any document.

ARTICLE II

BOARD OF TRUSTEES

Section 1. Number and Term of Trustees. The business, property and affairs of the Foundation shall be managed by a Board of Trustees composed of not more than twelve (12), and not less than three (3), persons (each a "**Trustee**"). Each Trustee shall have a term of office of one (1) year, and shall serve until his or her successor is elected and qualified, or until his or her removal, death or resignation.

Section 2. Election or Replacement of Trustees. The Trustees shall be elected by the Board of Directors of the Boys & Girls Club of Las Vegas, Inc (the "**Club Board**") subject to such qualifications as adopted by the Club Board from time to time. A Trustee may be removed by a majority of the voting power of the Trustees, at any time, with or without cause. The foregoing terms of this Section 2 notwithstanding, the Club Board and the members of the Club Board (each a "**Club Director**") are not "**Members**" as that term is defined under Chapter 82 of the Nevada Revised Statutes ("**NRS**") and, except as otherwise expressly provided by the Articles or these Bylaws, such persons shall have no rights otherwise accorded to Members by NRS Chapter 82, including without limitation, the right to remove any directors or trustees of the Foundation. A

Trustee may resign at any time upon written notice to the Foundation. Vacancies in the Trustees, regardless of how such vacancies occur, may be filled by a majority of the remaining Trustees, though less than a quorum.

Section 3. Club Board Chairperson and Treasurer. The Chairperson and Treasurer of the Club Board shall each serve as *ex officio* Trustees with voting rights.

Section 4. Advisory Trustees. From time to time, the Board of Trustees may appoint “**Advisory Trustees**” for terms expiring on a date chosen by the Board of Trustees. Advisory Trustees may be allowed to attend board meetings, and to participate in discussions, but shall not be allowed to vote. Advisory Trustees shall not be entitled to notice of meetings. Advisory Trustees may perform such duties as may from time to time be established by the Board of Trustees, and may serve on any Committees (as defined in Article VI), but without any voting rights.

Section 5. Power and Authority of Trustees. The business, affairs and property of the Foundation shall be managed by the Board of Trustees, which may exercise all such powers of the Foundation and do all such lawful acts and things as are permitted by law, the Articles and these Bylaws.

Section 6. General and Designated Gifts. If the Foundation accepts from a donor a contribution or gift to the Foundation earmarked by the donor for a specific purpose, the Board of Trustees shall direct that such contribution or gift, and any income therefrom, be used only for the indicated purpose as desired by the donor. Otherwise, all general contributions and gifts made without specific written instruction of the donor shall go into an endowment fund, the income from which may be paid out as designated by the Board of Trustees.

Section 7. Restriction on Power of Trustees. Notwithstanding the powers and authorities set forth in Article II, Section 5, above, the powers of the Board of Trustees shall be restricted as follows:

(a) No distribution of principal shall be made from the endowment funds of the Foundation without the express authorization of the Club Board, who shall determine if extraordinary and exceptional circumstances exist to justify removal of principal from the funds. Nothing herein shall preclude the Board of Trustees from distributing the following from the assets of the Foundation, whether such assets are real property, tangible or intangible personal property, or otherwise: (i) interest and other income received by the Foundation, (ii) any appreciation in the value of the Foundation’s assets, (iii) any contributions or gifts received by the Foundation.

(b) The Foundation shall not make any loan to a Club Director, Trustee or officer of the Foundation (“**Officer**”), or guarantee any indebtedness of a Club Director, Trustee or Officer, or otherwise use its credit to assist a Club Director, Trustee or Officer.

Section 8. Compensation of Trustees and Officers. The Board of Trustees shall have the power to pay salaries or other compensation to any Trustees, Advisory

Trustees, and Officers for services actually rendered by such persons for the benefit of the Foundation, but such salaries or compensation shall not be in excess of a reasonable allowance for such services. The Board of Trustees may reimburse a Trustee, Advisory Trustee, or Officer for authorized expenses incurred for services under this section.

ARTICLE III

MEETINGS OF THE BOARD OF TRUSTEES

Section 1. Meetings. The Board of Trustees shall hold not less than three (3) meetings during each calendar year. Such meetings may be held either within or outside of the State of Nevada, and may be held by teleconference, video conference, or similar communications media, by means of which all persons participating in the meeting can hear each other. Participation in a meeting pursuant to such communication means shall constitute presence in person at such meeting. The Board of Trustees may hold additional meetings at such time(s) and place(s) designated by the Board of Trustees.

Section 2. Special Meetings. Special Meetings of the Board of Trustees may be called by the President, and shall be called by the Secretary upon the written request of the majority of the Trustees.

Section 3. Quorum. Presence in person or by proxy of a majority of the Trustees shall constitute a quorum at any meeting of the Board of Trustees.

Section 4. Voting. Except as otherwise expressly provided by the Articles or these Bylaws, any matter submitted to a meeting of the Board of Trustees at which a quorum is present will be resolved by a majority of the votes cast thereon and the chair of such meeting will have an additional or deciding vote in the event of deadlock.

Section 5. Action Without a Meeting. Any action required or permitted to be taken at a meeting of the Board of Trustees or any committee thereof may be taken without a meeting if a majority of Trustees or committee members entitled to vote on the matter, as the case may be, consent thereto in writing. Such consent shall have the same effect as a majority vote of the Trustees or committee members of the Foundation at a board meeting duly called and noticed.

Section 6. Notice of Meetings. No notice need be given of regular meetings. Advance written notice of the time and place (but not necessarily the purpose or all of the purposes) of any special meeting, or change of date, time or place of a regular meeting will be given to each Trustee in person or by mail, electronic mail or facsimile addressed to him or her at his or her latest mailing address, electronic mail address or facsimile number appearing on the Foundation's records.

(a) Notice to any such person of any such special meeting will be deemed given sufficiently in advance when (a) if personally delivered or delivered by electronic mail, the same is transmitted at least 48 hours before the meeting date, or (b)

if given by facsimile, the same is transmitted and electronic confirmation of successful transmission is received at least 48 hours prior to the convening of the meeting; or (c) if given by the U.S. Postal Service, the same is deposited in the mail, with first class or airmail postage prepaid, at least five (5) days before the meeting date.

(b) Any person entitled to notice may waive call or notice of any meeting (and any adjournment thereof) at any time before, during or after it is held. Attendance of a person entitled to notice at any meeting will automatically evidence his or her waiver of call and notice of such meeting (and any adjournment thereof) unless he or she is attending the meeting for the express purpose of objecting to the transaction of business because the meeting has not been properly called or noticed.

(c) Any meeting, once properly called and noticed (or as to which call and notice have been waived as aforesaid) and at which a quorum is formed, may be adjourned to another time and place by a majority of those persons entitled to vote in attendance.

ARTICLE IV

OFFICERS

Section 1. Election. The Board of Trustees shall elect or appoint a President, one or more Vice Presidents, a Secretary, a Treasurer and such other officers as the Board of Trustees may approve. Two or more offices may be held by the same person; provided, however, that the same person shall not simultaneously hold the offices of President and Secretary. A person elected or appointed to any office will serve for a one (1) year term and continue to hold such office until a successor is elected, or upon the resignation or removal of such person.

Section 2. Removal. Any Officer or Advisory Trustee elected or appointed by the Board of Trustees may be removed by the Board of Trustees, whenever the best interests of the Foundation will be served by the removal; provided, however, that such removal shall be without prejudice to the contract rights, if any, of the person removed. Any vacancy occurring in any office of the Foundation by death, resignation, removal or otherwise shall be filled by the Board of Trustees.

Section 3. President. The President, who shall be a Trustee, shall be the chief executive officer of the Foundation, shall preside at all board meetings, shall be an *ex officio* member of all standing Committees (as defined in Article VI), and shall have general and active management of the business and activities of the Foundation. The President shall have the power to execute such bonds, mortgages, and other contracts as shall be designated by the Board of Trustees.

Section 4. Vice Presidents. The Vice President(s) shall have the same powers as vested in the President, but shall not exercise said powers unless acting under the delegation, authority or direction of the President or, in the absence or incapacity of the President, or unless specifically authorized by the Board of Trustees. The Vice

President(s) shall perform such other duties and have such other powers as the Board of Trustees may prescribe from time to time.

Section 5. Secretary. The Secretary shall attend all board meetings and record all the proceedings of such meetings in a book or books to be kept for that purpose, and shall perform like duties for the Committees, when required. The Secretary shall give, or cause to be given, required notices of all board meetings, and shall perform such other duties as may be prescribed by the Board of Trustees or President.

Section 6. Treasurer. The Treasurer shall have custody of the corporate funds, shall keep full and accurate accounts of receipts and disbursements in books belonging to the Foundation, and shall deposit all monies and other valuable effects in the name and to the credit of the Foundation in such depositories as may be designated by the Board of Trustees. The Treasurer shall perform such other duties and have such other powers as the Board of Trustees may prescribe from time to time. The Treasurer shall render to the Board of Trustees, at the regular board meetings, or when the Board of Trustees so requires, an account of all of the Treasurer's transactions and of the financial condition of the Foundation. If required by the Board of Trustees, the Treasurer shall give the Foundation a bond in such sum and with such surety as shall be satisfactory to the Board of Trustees for the faithful performance of the duties of the Treasurer's office.

Section 7. Other Officers. The Board of Trustees may appoint such other officers and agents, including without limitation the offices of Chairman, Assistant Secretary, Assistant Treasurer, and Vice President of Development, as it deems necessary. Such other officers may, but need not, be Trustees. Any such persons appointed shall hold their offices for such terms, and shall exercise such powers and perform such duties as shall be determined from time to time by the Trustees.

ARTICLE V

EXECUTION OF INSTRUMENTS

All contracts, conveyances, checks, drafts, and orders for payment of money, and deeds, conveyances and loan documents, shall be signed in the name of the Foundation by any two Officers or other agents designated by the Board of Trustees to have such power, the Chairperson (if any), President, Vice President, and Treasurer shall have such power without specific designation by the Board of Trustees. The Board of Trustees may authorize one or more persons to execute documents for any specific transaction.

ARTICLE VI

COMMITTEES

Section 1. Committee Appointments. The Board of Trustees may, from time to time, by resolution adopted by a majority of the Trustees, appoint one or more standing

or temporary committees (each a “Committee”) and vest such Committee with the powers of the Board of the Trustees in the management of the business and affairs of the Foundation to the extent provided by the Board of Trustees in the authorizing resolution, and subject to the Articles, applicable law and these Bylaws. In accordance with the limitations on committee actions set forth in NRS Chapter 82, a Committee shall not have the authority of the Board of Trustees in reference to the following matters: (a) the filling of vacancies on the Board of Trustees or in any Committee, and (b) the amendment or repeal of the Articles or the Bylaws, or the adoption of new Articles or bylaws. A member of any Committee may be removed, with or without cause, by the Board of Trustees. In the event any vacancy occurs in a Committee, it shall be filled by the Board of Trustees. Unless otherwise specifically required pursuant to a resolution adopted by a majority of the Trustees, a member of a Committee need not be a Trustee of the Foundation; provided, however, that each Committee must have at least two Trustees.

Section 2. Finance Committee. All investment decisions of the Foundation shall be made by a Finance Committee. The Finance Committee shall be composed of three (3) Trustees, who shall be elected annually by the Board of Trustees. The Finance Committee shall submit its annual report regarding the financial condition of the Foundation to the Board of Trustees at a board meeting. The Finance Committee shall have the power to designate any agent to manage the assets and investments of the Foundation.

ARTICLE VII

GENERAL PROVISIONS

Section 1. Fiscal Year. The fiscal year of the Foundation shall coincide with the fiscal year for the Club Board, but may be amended to coincide with the calendar year by resolution of the Board of Trustees.

Section 2. Amendment of Bylaws. The Bylaws may be amended, altered or repealed and new Bylaws may be adopted by the Board of Trustees by a vote of two-thirds of the Trustees present at a duly called and constituted board meeting at which a quorum is present, either in person or as otherwise provided in these Bylaws, provided that the full text of the proposed amendment, alteration or repeal shall have been delivered to each Trustee at least five (5) days prior to the meeting.

Section 3. Indemnification. The Foundation shall, to the fullest extent permitted by Nevada law, indemnify the Trustees and Officers of the Foundation with respect to liabilities and expenses arising out of any action, suit or proceeding in which they become involved by reason of their affiliation with the Foundation. Nothing contained herein shall prevent the Foundation from obtaining appropriate liability insurance for any of the foregoing. Notwithstanding the foregoing, in no event shall this Section 3 be interpreted, construed or applied to permit payment of any amount, payment of which would give rise to any liability for taxes or penalties under Chapter 42

of the Internal Revenue Code of 1954 (or any successor section), if the Foundation is at such time a private foundation.

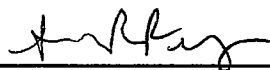
Section 4. Dissolution. Upon dissolution or other termination of the Foundation, any assets remaining after all debts of the Foundation have been paid shall be disposed of as provided in the Articles.

Section 5. Purpose. These Bylaws are adopted for the sole purpose of facilitating the discharge, in an orderly manner, of the purposes of the Foundation. These Bylaws shall never be construed in any way as to impair the efficient operation of the Foundation.

CERTIFICATION OF ADOPTION
