Research - The Hydrocephalus Association awarded two new Established Investigator grants totaling \$400,000 to scientists studying the production, flow and regulation of cerebrospinal fluid. We extended the grant cycle for two of our Mentored Youth Investigator (MYI) grants, and provided funding for the second year of another MYI. We started and are close to finalizing a study of the State of Public Funding on Hydrocephalus Research. We started planning for a special Hydrocephalus Research Conference to be held in 2012.

4b (Code) (Expenses \$ 455,143 including grants of \$ 0) (Revenue \$ 0)

Public Support and Education - The Hydrocephalus Association provides direct Public Education and support by organizing and supporting 29 active Support Groups that held 69 support group meetings for patients and families during 2011, awarding scholarships to 8 students with hydrocephalus who are pursuing post-secondary education, publishing an on-line resource library that was populated with almost 400 new articles in 2011, providing direct support to tens of thousands of patients and families by answering questions and providing referrals via telephone, email and through social media channels, and publishing a full complement of print and digital educational and resource materials for patients, families, and medical practitioners. HA's Teens Take Charge (TTC) program was fully operationalized to motivate and empower young people affected by hydrocephalus to advocate, raise awareness, and encourage peers. In 2011, TTC connected more than 800 teens through social media. HA also mobilized 10,000 individuals to participate in awareness-building Walks in 30 cities across the country.

Advocacy - The Association's advocacy work includes local awareness-building efforts, such as the Hydrocephalus Walks held in 30 cities across the country, mobilizing 10,000 participants in 2011. HA also supported state-level efforts to establish hydrocephalus awareness days/months. At the federal level, the Association focused on efforts to educate public policy makers on the challenges of living with hydrocephalus and the need for expanded research. HA participated in concert with other like-minded organizations in a special briefing for the Congressional Hydrocephalus Caucus.
