

The Foundation invests in the next generation of California lawyers by awarding scholarships to outstanding law students and recent law school graduates who intend to pursue public interest law careers and to outstanding law students from communities underrepresented in the membership of the State Bar. In 2011, the Foundation awarded more than \$100,000 in Public Interest Scholarships to 23 students, \$35,000 in Rosenthal Bar Exam Scholarships to 15 students, and more than \$157,500 in Diversity Scholarships to 21 students.

4b (Code) (Expenses \$ 296,663. including grants of \$ 248,608.) (Revenue \$)

The Foundation champions full and equal access to the justice system by providing financial support to nonprofit organizations, courts, the State Bar of California, and local, specialty, and minority bar associations. In 2011, the Foundation awarded \$248,608 in grants to law-related projects throughout California, with a special focus on funding projects supporting rural communities and language access projects.

4c (Code) (Expenses \$ 51,802. including grants of \$ 50,000.) (Revenue \$)

The Foundation educates the public about its rights and responsibilities under the law through its support of the State Bar of California's public education publications. In 2011, the Foundation provided a \$50,000 grant to the State Bar to support the publication of When You Turn 18: A Survival Guide for Teenagers, copies of which are provided free of charge to more than one million young adults, parents, teachers, and others over three years.

to the certified public accounting firm retained to conduct the Foundation's annual
audit and prepare its tax forms. After the CPAs prepare a first draft of the Form
990, the Executive Director and accounting consultant carefully review the completed
Form 990 and provide the CPAs with any corrections, edits, or changes. Once the
Executive Director and accounting consultant sign off on the Form 990, the draft is
circulated to the entire Board of Directors. The President and Audit Committee
Chair are asked to carefully review the Form 990 and provide any feedback. Once a
final draft is finalized, on behalf of the Board the President or Audit Committee
Chair signs the confirmation form that is sent to the CPAs.

The Foundation's Conflict of Interest Policy applies to "interested persons,"
defined as any director, principal officer, or member of a committee with Board
delegated powers, who has a direct or indirect material financial interest, as

Each year, the Personnel Committee, which is made up exclusively of Board members,

conducts a performance evaluation of the Executive Director and makes a

recommendation regarding her compensation package. The Committee solicits input

regarding the Executive Director's performance from Board Members and others outside

of the Board. The Committee reviews comparability data regarding executive director

salaries from a number of sources, including the Public Interest Clearinghouse, the

Center for Non-Profit Management, and other national surveys. In its deliberations,

the Committee also weighs the desire to reward excellence, encourage retention, and

avoid replacement costs. The Committee presents its evaluation and salary

recommendation to the full Board of Directors, which approves any adjustments to the

Executive Director's compensation package.
