The five full-time Priest Associates of Priests for Life travel both nationally and internationally to assist Catholic parishes and other Christian churches with support resources through parish missions and Bible studies. The organization accomplishes this through active and continuous cooperation with the diocesan structures of the institutional Catholic church.

International Expansion -

Priests for Life continued to extend its international outreach programs through education, communication, representation and advocacy through civil institutions and the Church.

In Geneva by participating in the World Health Organization annual meeting and private meetings.

Sending expert speakers to participate in international pro-life conferences (both public and private) for ten days in New Zealand and Australia; and in Europe (Italy, Austria and Germany)

African-American Outreach -

Alveda King, niece of the eminent civil rights leader Dr. Martin Luther King, Jr. and Director of the organization's African-American Outreach program. In this capacity, she networks with hundreds of prominent African-American pastors and Christian leaders, authors and media personalities.

In 2010, Alveda King organized the pro-life "Freedom Rides," by enlisting the participation and support of other leading African-American pastors to raise awareness to the sanctity of human life in the African-American community.

Media Outreach -

Priests for Life's cable television and radio programs reach over 22 million households throughout the United States through such media as the Eternal World Television Network (EWTN) on network cable, EWTN satellite radio and the Sky Angel satellite network.

Latin American Outreach -

This outreach of Priests for Life extends the ministry to the Spanish-speaking world (including Spain, Central and South America) through regular parish missions, a cable program on EWTN and social networking sites including Facebook, Twitter and YouTube.
