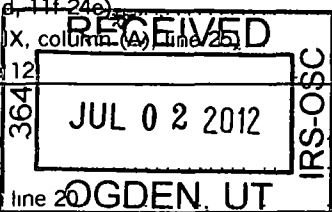

Working with local partners, we succeeded in stopping or suspending destructive dams from clogging important arteries of our planet. We helped convince the new Burmese government to stop the Myitsone Dam on the Irrawaddy River, and brought about the suspension of the Xayaburi Dam on the Mekong, the world's richest river in terms of fisheries. We helped delay the giant Belo Monte Dam in the Brazilian Amazon, and helped local partners to stop the Imambari Dam in Peru and the West Seti Dam in Nepal. In our efforts to strengthen environmental standards for dam projects, we convinced Sinohydro, the world's biggest hydropower company, to adopt a state-of-the-art environmental policy. A total of 112 actions organized by partners in 36 countries for the International Day of Action for Rivers testified to the strength and creativity of our network.

We continued to produce videos, reports, blogs and other materials in English and dozens of other languages to raise awareness of the social, economic and environmental impacts of damming rivers, and to showcase alternative technologies and methods to meet water and energy security for communities in the Global South. We released a Google Earth video entitled "Wrong Climate for Damming Rivers," in partnership with Friends of the Earth-International, which offers animations and geographic profiles of climate-resilient water and energy options in Africa, the Amazon and the Himalaya regions, and is available by DVD and on our website. Our media work resulted in hundreds of mentions in international print and television media.
