(Other Program Services)

The organization's program service accomplishments for the program listed on line 31: Operated a free food community outreach project which served free food 6 days per week to hungry persons and trained volunteers in collective organizational practices and vegetarian culinary arts. The organization operated this project from January 1 – July 1, 2011. On July 1, the organization transferred operation of the project to the East Bay Food Justice Project, a public charity exempt from taxation under Sec. 501(c)(3). All of the organization's funds related to the project (\$8,601) were transferred to East Bay Food Justice Project during 2011 for use in continuing the project. This transfer is listed on Part 1, Line 10, above.
