Our programs and services engage young students in powerful learning across the curriculum by helping teachers and scientists plan and implement exciting hands-on science by making use of the wealth of regional science and environmental learning resources.

Teacher Services: CRS provided over 900 Kindergarten through 6th grade educators with comprehensive information, reference, personalized support, web-based resources, training, and other support related to science teaching and learning. CRS served classroom teachers in 92 schools in the East Bay, including every elementary school in Oakland, Berkeley, and Emeryville. CRS provided over 200 custom research reports and responded to over 1,100 individual teacher requests. The teachers served in this program educate over 20,000 students, mainly in high-need, under-resourced public elementary schools.

4b (Code:) (Expenses \$ 91,318 including grants of \$) (Revenue \$)

Community in the Classroom/Bay Area Scientists in Schools: The CRS scientist volunteer program recruited, trained, and placed over 350 scientists into Kindergarten through 6th grade classrooms to present engaging, standards-based, hands-on science lessons. Scientists also serve as diverse, enthusiastic role models who inspire young students to learn about academic and career options in science. The program was renamed from CIC to BASIS (Bay Area Scientists in Schools) at the start of the 2011-12 school year. Scientist volunteer teams presented over 380 lessons in East Bay classrooms in 2011, engaging over 9,000 students in science learning activities. The lesson plans and related material lists, science content background, and teaching tips are made available to classroom teachers hosting scientist team visits; the materials are also archived and accessible on the CRS website.

Research and Resource Development: Research, convening, consulting and training projects targeting specific science education needs. CRS provided professional development and curriculum development services to school districts and informal education organizations. CRS provided coordination for site-based pilot projects involving middle school science support and delivery of scientist-led interactive science experiences in middle school settings. CRS convened an Advisory Council including thought leaders from education, academia, districts, foundations, museums, and other organizations working to improve the quality and quantity of K-6 science education.
