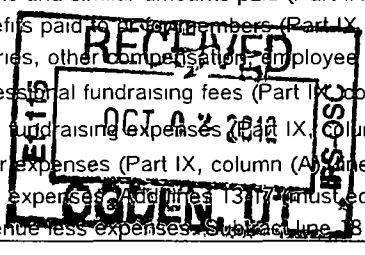

Strong Families:

In 2010, Expanding the Movement for Empowerment and Reproductive Justice (EMERJ), ACRJ's national movement building program, launched Strong Families, a 10-year initiative to change the way people think about, talk about and act in support of families. Strong Families is reclaiming the definition of "family" and advocating for changes that support families who are pushed to the margins such as LGBTQ families, immigrant families, low-income families and families headed by women of color. Strong Families grew to become the program through which ACRJ could advocate fo a range of social justice issues impacting families and build strategic alliances across social justice sectors, encompassing EMERJ's work. Key leaders in EMERJ transitioned to form the Strong Families Leadership Team.

The Strong Families initiative is a new home for people to collaborate across race, class, sexual orientation and gender to seek workable solutions that include all of our voices. The goals of Strong Families are to: Change the way people think about, feel about and act in support of families of all kinds; Build strong alliances across social justice sectors to expand the initiative's base of power; Change policy on the local, state and national levels to benefit the majority of families and; Mobilize communities to take action for issues impacting families.

In the first year of Strong families, ACRJ and nine organizations on the Strong Families Leadership Team helped build a membership base of 45 organizations from a range of social justice sectors that are taking concrete actions in support of the initiative. ACRJ provided critical capacity and support to allies in using Strong Families framing and messaging in numerous campaigns that align with the initiative's policy priorities. Some of the key campaigns we worked on include the following:

In May, ACRJ coordinated a Strong Families Mama's Day campaign. This campaign brought together allied organizations from across the country to send a united message about the important role of mothers, especially the ones who are overlooked by the mainstream. The campaign consisted of 20 blog posts that generated over 6,000 hits on the Strong Families blog; eight events; and a music video that got over 5,000 hits on YouTube.

During the summer, ACRJ mobilized 10 local groups to strategize and take action in having a series of racist, anti-choice billboards removed from Oakland. This multi-racial campaign garnered media coverage 12 times, gathered 4,200 signatures on a petition protesting the billboards and inspired public statements of support from several local elected officials.

ACRJ worked with fellow Strong Families member Center for Young Women's Development (CYWD) to push for the passage of a California bill which would end the shackling of women in prison during labor and delivery (a similar bill was vetoed in 2010). A petition, created by ACRJ to support the bill, garnered 1,200 signatures. Although the bill was ultimately vetoed due to strong opposition from the Sheriffs'

Youth Organizing Program:

ACRJ's Sisters in Action for Issues of Reproductive Empowerment (SAFIRE) program offers comprehensive skill building and leadership experience opportunities for young Asian women in Oakland. In 2011, 86 Asian girls went through the SAFIRE program, the largest number of young women we have ever served. The summer of 2011 also featured the first-ever Young Men's Program, which had a parallel curriculum to the SAFIRE program. For seven weeks, 15 young men from low-income immigrant or refugee families came together to identify and challenge gender roles, homophobia, racism and patriarchy within themselves and in their communities. Moving forward, our SAFIRE and Young Men's Program have merged to form our Youth Organizing Program.

Youth met regularly after school and during the summer to explore issues of sexuality using a Strong Families framework. Topics included dating violence, patriarchy, homophobia, sexuality education, gender, and body image. For the first time, the youth participated in a series of overnight outdoor retreats in November 2010, April 2011 and August 2011 at the Occidental Arts and Ecology Center (OAEC) in Sonoma County, California. These retreats offered a rare opportunity for the young women to spend a significant amount of time outdoors, deepen their analysis of the link between the environment and families, and experience first-hand how the intersections of climate justice and reproductive justice are applied in real life.

Our Spring Session focused on uplifting the needs of young mothers and young women in juvenile detention centers. Program participants learned about the stigmas and issues impacting many young women. The youth participated in a Mamas Day event in front of San Francisco City Hall, speaking out in the media about the importance of supporting young parents. During the Summer Session, which featured our pilot program for young men, the youth explored issues of gender, bodies and sexuality. They had the opportunity to transform their experiences in the program and with these issues into performances for a community event attended by over 200 friends, family, and community members. Each performance was developed and executed by the youth and explored personal issues of sexuality education, patriarchy and gender in their communities. Our Fall Session focused on outlining a plan for our 2012 Participatory Action Research Project. The project focused on demonstrating the need for sexuality education that addresses issues specific to students of color, immigrant students and LGBTQ students. Participants organized a plan for conducting focus groups, developing survey questions, and analyzing data for the following year.

Forward Stance:

Forward Stance is a mind-body approach to organizing and movement building that allows us to face challenges and identify strategic solutions with clarity. In November 2011, ACRJ successfully completed the third and final part of our 18-month Forward Stance Leadership Initiative (FSLI). Two participants from eight organizations engaged in leadership development and explored how to integrate the practice into their organizational work and culture. At the completion of the

training, we conducted an evaluation that revealed the positive impact Forward
Stance has on both participants and organizations.

ACRJ has provided technical assistance to Strong Families Leadership Team members
including California Latinas for Reproductive Justice (CLRJ), Western States Center
and Young Women United, who have instituted a weekly Forward Stance practice at
their organizations, following the third FSLI training. At each of these
organizations, a critical mass of staff members are using Forward Stance to
strengthen and align their work, problem solve and support strategic thinking. In
addition, three other Strong Families members began to incorporate Forward Stance
practice into their staff development.

ACRJ also integrated Forward Stance into the culture of our Strong Families
Leadership Team convening in November 2011. The convenings are an important time
for leaders in Strong Families to align work plans and set strategic agendas for the
coming year. Weaving Forward Stance practice into the agenda has helped to inform
our development as a group and has also informed our strategic thinking and
planning.

Finally, Forward Stance was incorporated into our Youth Organizing Program last
year. The practice helped to unify the core group of youth leaders who led the work
of the program. The youth were able to align with one another by practicing taiji,
breath and stance together as a group.

A copy of the approved Form 990 will be provided to all directors, and a public disclosure version (masking the names and addresses of major contributors) will be posted on the organization's web site. A file copy will be kept in the regular finance department files.
