California Farmlink builds local food systems and keeps farmland in production by providing beginning and low-resource farmers with tools to lease and purchase land, access capital, and improve business and financial management skills.

Linking Program: Our core land linking program matches retiring farmers and landowners with beginning and aspiring farmers, promoting continued agricultural production and the protection of farmland.

Workshops and Technical Assistance: Farmlink conducts workshops and one-on-one technical assistance throughout the state in collaboration with local farm groups, tailored to meet the needs of local farmers. Topics typically include land tenure and leasing, farm succession planning, business and financial management, financing, and mentorships. FarmLink serves as a clearinghouse of information and referrals for these topics. Services are provided free or at minimal cost to farmers.

4b (Code ) (Expenses \$ 242,490. including grants of \$ 0.) (Revenue \$ 19,746.)

The farm loan program provides low-interest, flexibly structured operating and infrastructure loans to farmers who have little access to conventional sources of financing. FarmLink staff provide assistance to applicants in putting together loan packages, projecting cash flow and managing finances as well as follow-up coaching to ensure long term sustainability of farm businesses.

4c (Code ) (Expenses \$ 30,344. including grants of \$ 0.) (Revenue \$ 24,344.)

An agricultural Individual Development Account (IDA) program is the first of its kind in the nation and was the inspiration for a farm IDA program authorized in the 2008 Farm Bill. The IDA program allows farmers to build equity by putting money each month into a savings account and having that money matched by FarmLink and other partners, usually at a ratio of 3:1 or 2:1. Farmers receive training in financial management during the program and at the end of the savings period, the money may be used to buy a farm asset such as a tractor or irrigation equipment, or to put a down payment on land.
