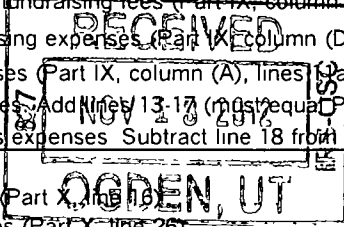

The Frank P. Doyle Trust distributes its net income in excess of \$2,000 (see item 4(b) below for the distribution of the \$2,000) to Santa Rosa Junior College for the provision of scholarships (of varying types and for varying purposes) to students selected by the college. As approved by the Superior Court and due to financial constraints caused by the current recession including the suspension of dividend payments to the Trust, no distributions were made during 2011. During 2011, the Trust increased borrowings from \$579,190 to \$709,493 to finance ongoing operating costs (including interest expense, insurance, professional fees and other compliance costs).
