In 2011 the organization supported the library by providing \$32279: \$21872 for microfiche and IT equipment for outreach to the community; \$2191 for children's programs; \$3537 for teen and other programs and staff support; \$1178 for New York Times subscription; \$3500 for library collection enhancement.

2. (pg 1, line 16): Other expenses: \$ 679 Officer insurance from county; \$209 hospitality; \$55 licenses and fees; \$908 book mender expenses; \$424 publicity; \$415 for sorting and office supplies.

3. (pg2, Part III): The primary purpose of the Friends of the Davis Public Library is to raise funds from the sale of used, donated books and magazines. The bulk of our revenues are given to the public library for their purchase of books and audio visual materials to augment the circulating and reference collections. We also provide funds to the library for their programs and workshops for the Davis community.
