Record levels of revenues were achieved in 2011 with 20 different major sponsors participating in the circuit through this member service.

ATP successfully promoted the interests of players and tournaments, improved the public perception of tennis as a major global sport, promoted the future of the sport and encouraged interest in the sport of tennis through its global marketing services and initiatives. ATP digital channels received more than 231 million visits in 2011 - a 35% increase in 2010. ATPWorldTour.com received an average of 3.5 million unique visitors per month in 2011. The ATP Uncovered Magazine Show reached more than 400 million viewers in 150 countries. Roger Federer was named as one of the most recognized sports athletes worldwide.

Sanctioning, scheduling and administering a circuit of professional tennis events is an ongoing and significant function of ATP. During 2011, ATP administered the ATP circuit consisting of 62 events with record prize money of \$72 million and a second tier circuit of 150 events. A bonus pool of \$5.4 million was paid to players who participated in the circuit. ATP owns and manages the year-end ATP World Tour Finals event and achieved attendance of over 250,000 for the 3rd straight year, earning the title as the world's largest indoor tennis event.
