Golf for Greenville (GFG) raised \$315,000 for the Ronald McDonald House, YWCA and Safe Harbor. This accomplishment was achieved with the help of a record 87 generous sponsors and 367 golfers. Program services by expense incurred include: Tournament expenses (\$79,961), the Pairings Party expenses (\$19,356), and Prizes/Auction expenses (\$6,178).

4b (Code:) (Expenses \$ 158,840 including grants of \$ 110,000) (Revenue \$ 116,070)
Fluor Cares team in Sugar Land, TX coordinated a community golf tournament that raised funds for two (2) non-profit organizations: 1) Fort Bend Rainbow Room, and 2) Second Mile Mission, that were selected through an application process to support their programs and services assisting families in financial crisis, and to provide funding for "Back to School Drive" for upcoming school year for abused and neglected children. These children are provided with new school supplies and tools to help them to succeed in the classroom.

Building Futures is an annual community outreach project in which Fluor Cares teams provided backpacks filled with school supplies to schools and youth organizations benefiting children. Over 1,200 backpacks and provide classroom supplies for the Boys and Girls Clubs of Capistrano Valley, Santa Ana, Long Beach and Betsy Ross School in Anaheim. 400 backpacks and provided additional supplies were distributed to public schools children in Irving, Dallas and Grand Prairie, TX. Over 800 backpacks with school supplies were handed out for grades K-5th in Houston, TX. 970 backpacks were filled and distributed to public school children in Greenville, SC.
