The Foundation provided support for the rebuilding of the Santa Barbara Cottage Hospital as required by the State of California unfunded Senate Bill 1953, requiring compliance with the upgraded seismic standards. The Foundation also supports medical education in the Community by providing grants to Santa Barbara City College’s Nursing Program and by providing scholarships to individuals pursuing a nursing degree.
