The Healthcare Foundation at GAMC provides a fund raising function to support the mission of Glendale Adventist Medical Center and programs to improve the quality of life and health in our community The funds are transferred to the hospital based on the grantors and donors intent A significant portion of Management and General expenses are paid for by Glendale Adventist Medical Center and accounted for as a department of the hospital in its support of the Foundation During 2011, a focus of the Foundation's fundraising was to raise \$1 million toward the purchase of a faster, safer and more precise Toshiba Premium CT scanner This scanner incorporates the latest technologies to significantly reduce the patient exposure dose by up to 40% while optimizing resolution At the same time it provides faster scan times, resulting in a reduction in the amount of time the patient spends on the table while increasing patient comfort and satisfaction This new technology allows GAMC to support patients where immediate diagnosis is especially critical, as in the cases of heart attack and stroke patients GAMC has been designated a STEMI (Heart Attack) Receiving Center and an Advanced Primary Stroke Center, one of only a few in Los Angeles County and requires a STEMI and Stroke Alert Team to be available 24/7 The following story illustrates the power of quick diagnosis that a qualified medical center such as GAMC is able to provide with the right tools and a dedicated, well trained staff Helen Ostendorf, 92, was active in her church, drove every day, and took care of her husband of 69 years, Ozzie, in their Glendale condominium where the two live independently All that threatened to change on April 20 Helen and Ozzie were enjoying breakfast with a friend at a restaurant when suddenly Helen couldn't move or talk "We were sitting having a second cup of coffee and suddenly I thought 'what's the matter with me?'" Helen said "I could see everything around me, but I couldn't respond to it My husband said 'call 9-1-1 ' I thought, I'm fine, why is everybody rushing around and calling 9-1-1?" Helen was brought via ambulance to GAMC where she was treated for an ischemic stroke with thrombolytic therapy, or TPA, a clot-busting medication that has proven effective if delivered within three hours from the onset of stroke symptoms Within a day, Helen's ability to speak was restored and her right side paralysis was one She left the hospital after just a week with her functionality almost fully restored "This kind of outcome with a stroke patient of her age is unheard of," said Lance Lee, MD, medical director of GAMC's Advanced Primary Stroke Center "The fatality rate for stroke skyrockets for patients over 80 And most who get discharged go to a rehabilitation facility with severe neurological deficits, not immediately back home "Dr Lee credits Helen's success to the skills and fast action of the Glendale Rescue 26 paramedics, the GAMC emergency team and hospital stroke experts "Helen's story is extraordinary and the perfect example of how a quick response to the symptoms of stroke can make a big difference-even at age 92," said Dr Lee Helen is now back home and, while she can no longer drive, she still lives independently Although Helen's speech is fine, she sometimes has trouble remembering words and is receiving home visits from a speech therapist A physical therapist and an occupational therapist also visit Helen at home to help her improve her balance Helen has nothing but praise for GAMC and Dr Lee "It was fabulous," she said "I call it a five-star hotel The staff was great Dr Lee was excellent He's a very warm, nice person And the nurses were most attentive When I left the hospital, they all lined up at the nurse's station and said goodbye "
