After two years of surveys, research and analysis, the Sierra Club Angeles Chapter volunteers published their Water Conservation Scorecard of over 80 local water agencies, rating them on their regulations and rate structures as compared to a national model The expectation was that those who received low ratings would improve their policies to increase water conservation by their customers A dozen of them promptly did just that when the Los Angeles Times newspaper picked up the story Support took the form of underwriting part time staff assistance, brochures, and extra copies of the local newsletter for use at fairs and open-house, environmental education events
