PARTICIPANTS RODE THEIR MOTORBIKES FROM HARLEY DAVIDSON OF GLENDALE IN GLENDALE, CA TO CASTAIC LAKE IN CASTAIC, CA (A 50-MILE RIDE). AT THE CASTAIC LAKE, PARTICIPANTS ENJOYED A CONCERT WITH FOOD & DRINKS. PARTICIPANTS IN CARS ALSO CAME TO CASTAIC LAKE FOR THE MINIMUM DONATION OF \$65. FOR THEIR \$65 DONATION, EACH PERSON RECEIVED A LOVE RIDE PIN AND PROGRAM. PRE-REGISTRANTS ALSO RECEIVED A LOVE RIDE 28 PATCH. EVERYONE ATTENDING IS ENCOURAGED TO MAKE ADDITIONAL DONATIONS EITHER PERSONALLY OR BY COLLECTIONS FROM FAMILY, FRIENDS, COLLEAGUES, ETC. AND ARE GIVEN INCENTIVES FOR THE DONATIONS. THIS YEAR INCENTIVES INCLUDED OPPORTUNITY TICKETS FOR VARIOUS PRIZES.
