- A New Way of Life's five reentry homes served a total of 40 women and 13 children during 2011.
- We were able to provide services for about 1/3 the cost of incarceration.
- On average, seven out of every ten women who received services have been able to maintain sobriety and make successful community reentries while living in our homes.

ANWOL's Reentry Legal Clinic provides a range of probono services to formerly incarcerated people Services assist clients with overcoming barriers to employment in order to promote successful community reentry:

- Thirteen attorneys, 53 community volunteers, and 192 UCLA law school students provided client services through the clinic.
- Staff attorneys filed 638 post-conviction relief petitions (average of 53 petitions per month), of which:
 .388 petitions were granted, 62 were denied, and the rest are pending.

- Three women subsequently acquired paid internships with A New Way of Life.
- A new chapter of All of Us or None was formed in Riverside.
