 Education/Nutrition Programs: Through the education program, 138 children received sponsorships for tuition and expenses at Shalom School. Children in the sponsorship program successfully graduated to the next grade level at the end of the school year. Graduates of Shalom School who have received scholarships through the Education Sponsorship program have been successful in securing positions in the business community. All children receive an excellent basic education. High school students also receive specialized training in a professional career category preparing them for the job market. Books for the public school curriculum are also donated through the program. Over the past 12 years, the Organization has provided an education sponsorship for more than 1,300 students making a great and

 Housing and Community Development: In 2011, through the construction program, 3 houses were built for extremely poor families in need. Nearly 110 volunteers from the United States and Guatemala worked together to build the homes and better the lives for the people. These efforts included the distribution of information regarding the conditions of the working poor in Guatemala and the impoverished living conditions in this developing third world country. Hundreds of individuals and organizations were educated about the needs affecting Guatemala, through the Construction Outreach Program, many supplies were also collected and distributed including clothing, toys, shoes, construction tools, books, educational supplies, computer technology and more. The Shalom Foundation has built more than 70

 Medical Program: The medical program began in 2003 with the bringing of a young girl to Nashville for life-saving surgery. Medical care was provided at no cost by the doctors and the hospitals that performed the surgery. Through 2011, the medical program has sponsored two other children to travel to the US for surgeries. In March 2011 Shalom completed the construction of the Moore Pediatric Surgery Center in Guatemala City. Currently, medical professionals, who partner with The Shalom Foundation work at the Moore Center on short mission trips. In 2011 more than 150 surgical procedures for children were completed at the Moore Center. Efforts are continuing to involve business leaders and medical professionals in the United States and Guatemala to share in utilizing the
