- 1) Application: The candidates are required to file application form and submit it with their proposals.
- 2) Screen & Evaluation: Designated professional staffs are responsible for screening and evaluating applications with proposals, then give recommendations for grant action.
- 3) Review & Approval: The application is reviewed and approved by different level of officers, special management committees, and directors based on the purpose and the amount of grants.
- 4) Periodically Reporting: The beneficiaries are required to provide regular progress reports on quarterly, half yearly or annually basis.
- 5) Final Assessment: When the grant is completed, foundation checks its compliance and effectiveness through expenditure data, reports, and field investigation if necessary.

Besides, to facilitate the monitoring locally, our largest beneficiary, Fudan University, sets up a Grant Administration Office on campus full of experienced professional staffs. The office is responsible to both the foundation and the university's grant management.

In other words, foundation can get sufficient information of all the grants and exercise supervision with the assistance of the office.
