Local

Seven high school students were provided full scholarships to participate in the Rotary Youth Leadership Awards Program. The three day training for potential leaders was held at Kilauea Military Camp. It encourages leadership of youth by youth. Gail Takaki led the project with support by many other club members.

- Four Interact Students and one foreign exchange student attended the Oahu **Interact Convention** along with club advisors and Rotarian Kui Costa. The Waiakca High Interact Club won three awards:

- Rotary Advisor of the Year Ed Hara
- Faculty Advisor Gloria Kobayashi
- Best Scrap Book

Gift certificates were given to two faculty who advise the Waiakea High School Interact Club. The advisors supervise the twice weekly meetings throughout the school year. They also provide supervision for after school activities. Numerous Rotarians participate in the Club's activities.

- Back packs and other school supplies were provided to homeless children through *Project Hawaii*.
- Funds were sent to the Kona Sunrise club to support their *Project Aloha* to provide holiday gifts to military personnel deployed on missions.
- To promote literacy, software was purchased for the Computer Assisted Learning Center located at the Hilo Public Library. The center is available year round.
- Ken Yeo was the recipient of the Hilo Rotary Club Foundation's annual \$1,500 scholarship for business students at the University of Hawaii, Hilo. He is a 2nd year accounting Student.
- Hilo Medical Center Foundation received \$12,255.80 for their Rural Residency Program. The goal of the program is to address the acute shortage of physicians in East Hawaii.
- 200-250 people were fed lunch through the contribution to the Salvation Army lunch program.

International

- The \$20,093 raised in 2010, was spent in 2011 to build the Nadi Handicapped School Hearing Lab in Fiji. A project of the Rotary Club of Nadi, it will provide free services to hearing impaired children. The lab will test children suspected of having hearing problems and manufacture hearing aids as needed. The center will serve children in the Western & Northern Districts of Fiji and outlying islands. **Steve Handy** raised the funds from his family, fellow Rotarians and golfer Vee-jay Singh.
- The foundation and club members contributed close to \$20,000 to the Tsunami disaster relief efforts in Japan. \$3,000 came from the foundation's unrestricted funds; the balance came from individual club members. The club worked with the Hiroshima-South Sister Club, Rotary District 5000 and individual club members' contacts in Japan to get the funds where they were needed.
- The foundation helped fund supplies for the 35 guests visiting from our sister club - the Rotary Club of Hiroshima South.
- The foundation provided netbook computers and digital cameras for the Ka'u International Cultural and Literacy Project which connects schools in Hawaii, Alaska, Russia and Thailand. The principal of Ka'u High School said "she hopes it will promote a greater appreciation of the students' home and help them share it with others around the world". Jon McElvaney and Steve Yoshida are leading the club's efforts on this International and local service project.
