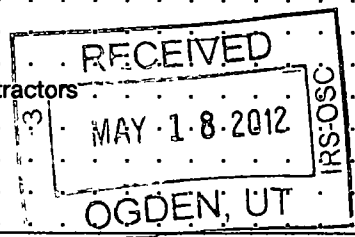

**We have also incorporated another element into our volunteer and cultural immersion programs, which allows volunteer program participants the opportunity to travel to Cusco/Machu Picchu and learn about the Incan culture and archaeological ruins. This program serves to educate program participants about the history and culture of Peru during the time of the Incas. The program is optional and has an approximate cost of \$ 650 including flights, tickets, guides and accommodations in Cusco.**
