LAST YEAR THE OUTBACK BOWL PAID A COMBINED \$7 MILLION TO THE SEC AND BIG TEN CONFERENCES. THE OUTBACK BOWL HAS PAID IN EXCESS OF \$100 MILLION OVER ITS BRIEF HISTORY TO NCAA MEMBER INSTITUTIONS.
