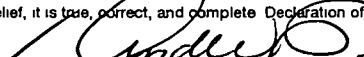
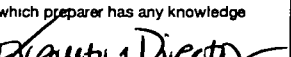
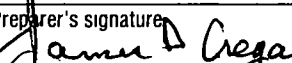

- ▶ Information about the capability of the leadership to implement the proposed project.
- ▶ Short- and long-term outcomes anticipated and plans for assessing achievements.
- ▶ Grant amount needed.
- ▶ A recent financial statement, audited if possible.
- ▶ A statement about the total agency budget and project budget, if different.
- ▶ A statement about other funding sources for the agency and/or project, specifying both committed and projected sources of support.

If you are requesting \$1000 or less, we may be able to evaluate your request based on the information contained in your letter of inquiry. However, you must also include a copy of your 501(c)(3) determination letter and a copy of your organization's current budget.
