InterVol recovered and donated unused medical supplies to approximately 50 organizations, benefiting people abroad and in the Rochester area. Teams of health care professionals traveled to Belize and Haiti, areas with acute medical personnel shortages, serving approximately 10,000 patients. InterVol also provided opportunities for civic engagement and service-learning through ongoing volunteer activities for approximately 200 students.
