In addition, the Organization has provided resources to communities disproportionately affected by the death penalty by providing reentry resources to released clients, and providing resources to maintain strong ties between inmates and their families.

These include promoting literacy and school attendance, as well as financial assistance with phone bills, or administrative assistance for visiting families.

The organization is creating a series of short videos focusing on storytelling by communities adversely affected by the death penalty.
