ARTICLES OF MERGER

Pursuant to the provisions of the District of Columbia Non-Profit Corporation Act, the undersigned corporations adopt the following Articles of Merger for the purpose of merging the corporations into one of such corporations:

FIRST: The following Plan of Merger was approved by each of the undersigned corporations:

Plan of Merger

1. American Machine Tool Distributors' Association ("AMTDA"), a District of Columbia non-profit corporation, shall be merged into AMT - The Association For Manufacturing Technology ("AMT"), a District of Columbia non-profit corporation, which shall be the surviving corporation ("Surviving Association").
2. AMT - The Association For Manufacturing Technology shall be the name of the Surviving Association.

3. Terms and Conditions of the Merger:

4. The Articles of Incorporation of the Surviving Association shall be the Articles of Incorporation of AMT that are in effect immediately prior to the merger, with the following amendment to Article II:

Article II shall read in its entirety as follows:

The purposes for which this Corporation is organized are to promote the progress and development of high standards of manufacture, marketing, distribution, safety, technology, industrial and public relations, business management and ethics in the manufacturing technology industry of the United States, to stimulate interest in and demand for manufacturing technology products, and to represent and advance the common lawful interests of the manufacturing technology industry before the public, industry and the government.

5. Upon the effective date of filing of the Merger with the District of Columbia Department of Consumer and Regulatory Affairs, the Bylaws as set forth in the Agreement of Merger entered into by AMTDA and AMT shall be the Bylaws of the Surviving Association, until further amended as specified therein.

SECOND: As to each of the undersigned corporations, the Plan of Merger was adopted in the following manner:

1. The Plan of Merger was adopted by the board of directors of AMTDA by unanimous vote of those directors present and voting at a meeting duly called and held on November 30, 2011, and was approved on January 16, 2012, in accordance with Section 29-409.04 of the Nonprofit Corporation Act of 2010 by mail ballot of more than majority of a quorum of the voting members of AMTDA.

2. The Plan of Merger was adopted by the board of directors of AMT by unanimous written consent effective on December 7, 2011, and was approved on January 13, 2012, in accordance with Section 29-409.04 of the Nonprofit Corporation Act of 2010, by mail ballot of more than a majority of a quorum of the voting members of AMT.
