Thus the AWP used is not an independent valuation and Thomson Reuters does not perform any independent analysis to determine or calculate the actual AWP paid by providers to wholesalers. Because of this lack of independence, this otherwise observable market data is considered a Level 3 input valuation. There can be significant differences in the values of AWP provided by the Red Book and other sources. The Organization uses the Red Book to develop its unobservable inputs without undertaking all possible efforts to obtain information about market participation as it believes it provides the most consistent fair value measurements. The Organization also believes any differences in valuations are consistent with the health care environment and its market participants.
