**The Maasai Stoves and Solar Project:**  
 This projects works with the Maasai of northern Tanzania. With the women of the villages of Monduli Juu, the ICSEE has designed a wood stove which gets the smoke out of the houses, conserves wood, and lessens women's wood gathering labor. The local people are being assisted in all aspects of stove production. The ICSEE is assisting women start stove businesses. Women's teams are being organized and trained to install and maintain stoves. Photo voltaic systems for light are being introduced to eliminate kerosene burning as the primary light source in the Maasai homes. Ways to help the Maasai spread these benefits to many villages are being developed.

**Powering Potential:**  
 This project brings computer capacity to schools in small towns and remote settings in Tanzania. The first installation is in Karatu in the Ngorongoro district. Solar powered computers and satellite disks are installed and people trained to use them well, bringing, general computing power, and internet services to Tanzanian teachers and students.

**The Palestinian House of Friendship**  
 This is an educational center and summer camp for youth in Nablus, the West Bank. It provides safe and constructive learning opportunities for the community, providing immediate benefits for the children and their families and in the long term, contributing to the peaceful security of all.
