The Organization specialized in cases relating to sex discrimination, sexual harassment, family and medical leave, discriminatory working conditions, family responsibilities discrimination, and unequal treatment and discrimination in educational institutions receiving federal funding. The Organization utilizes litigation to advance the rights of the most marginalized women workers and students, particularly low-income, immigrants, and women of color.

Educated the public through its "Know Your Rights" brochures on Sexual Harassment at Work, Sex Discrimination, and Family and Medical Leave and Pregnancy Discrimination. In addition, the Organization distributed information about legal and economic issues affecting women via presentations, its website, e-newsletter and general brochure, as well as acting as a resource for the media.
