- 1) Nominees for our Award agree to undergo a thorough vetting and review process including scrutiny by an independent investigative team hired to assure our Nominees are of the highest caliber even before we first consider them as Award Winners. On site investigations assure us that all Nominees are in fact delivering the services they claim to be, and that services are being to provided to vulnerable children as specifically required by World of Children.
- 2) Finalist Nominees are required to submit a Formal Action Plan outlining how they propose to spend funds if granted, including performance benchmarks and measurable deliverables. These proposals are reviewed by Board and staff.
- 3) Once Nominees advance to the next level and are announced as official Award

Winners, they must sign a formal Grant Use Commitment document pledging to use grant funds only in ways that are consistent with World of Children policies and procedures.

- 4) We employ a two-year grant relationship for Award Winners of \$50,000 or more. This means Award Winners will receive only 50% of grant funds in year one, and 50% of funds in year two assuring that World of Children can establish an on-going relationship best enabling us to monitor use of funds.
- 5) After year one, Award Winners must submit documentation demonstrating they are in fact achieving performance benchmarks as agreed, prior to the second phase of funds being released. This report is reviewed and accepted, or refused by Board Members and staff. Only if the report is accepted, will the balance of funds be released to the award winner.
- 6) After the two year grant fund period a final report is issued outlining outcomes as agreed. This report is reviewed and accepted, or refused by Board Members and staff.
- 7) Award Winners are highly motivated to meet the requirements imposed by the World of Children Awards, as peak performers become part of a global network of our Honorees sharing information about additional partnerships and resources available. Additional funds are also available for a second round of funding, yet only if the Award Winner performs well and meet our standards.
- 8) Award Winners receiving grants of less than \$50,000 may be eligible to receive grant funds in one year, yet are still obliged to adhere to the same general reporting and oversight systems outlined above.
