Each year between 140 and 160 officers are killed in the line of duty and their families and co-workers are left to cope with the tragic loss. COPS provides resources to help them rebuild their shattered lives. Over 300 Indiana police officers have been killed in the line of duty, and their sacrifices will never be forgotten.
