Communications: Communications staff produced weekly Labor Update for affiliates and members providing an update on issues and events of concern to union members, helped to design and execute a media campaign and grass roots effort against a proposed "Right to Work" constitutional amendment, and provided assistance to the BCTGM's communication efforts in response to the lock out conducted by American Crystal Sugar. Officers participated in Editorial Board meetings with various newspapers throughout the state concerning legislative issues.

Legislative Conference: We planned and hosted a legislative conference attended by over 200 union officers and activists. Workshops were held concerning legislative issues, and the 2012 electoral season.

4b (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)

Legislative: We organized and coordinated a comprehensive lobbying effort among our affiliates to ward off a "Right to Work" constitutional amendment and other attacks on organized labor including attempts to weaken the prevailing wage law, to dismantle the Public Employee Labor Relations Act, and to eliminate seniority rights. We also coordinated lobbying efforts in support of a Capitol Bonding Bill and a proposal to build a new stadium for the Minnesota Vikings. Efforts included recruiting volunteers from the various unions to attend legislative hearings and demonstrations outside of the House and Senate Chambers.

Political: We worked with affiliates to develop a comprehensive Labor 2012 plan to guide our electoral efforts in 2012. We also organized "Accountability Sessions" in various state legislative districts with legislators.

Labor Pavilion and State Fair: We continued to schedule daily programming through the run of the Minnesota State Fair through the use of union actors and musicians along with demonstrations of workplace skills by participating unions.
