During the year ended 03-31-2012 this entity suffered a major disaster on May 22, 2011 due to the devastating tornado that hit Joplin, Missouri, a Presidentially declared disaster area. The tornado virtually destroyed the entire building and contents of this entity.

As of year end, 03-31-12, this entity has not received all insurance proceeds due it as negotiations continue with the insurance companies. Once the final insurance proceeds are received in year end 03-31-13, an involuntary conversion gain under IRC 1033 will be recorded and all accounts adjusted accordingly. Most likely, the entity will respend all the insurance proceeds thereby deferring any gain.

This return has accounted for the partial insurance proceeds received as well as the partial replacement items as of March 31, 2012 by recording the net of this amount on this balance sheet as a liability labeled "involuntary conversion deferred gain" in the amount of \$894,655.00.
