UNUSUAL CONTRIBUTIONS
For purposes of the public support test under IRC 509(a) (1)

This document is intended only to provide guidance in identifying unusual contributions made to the Kansas Masonic Foundation. The guidance in this document may need interpretation or modification based on facts and circumstances surrounding a particular contribution.

The Foundation actively solicits and receives public support in the form of contributions from the public. Solicitation activity concentrates on the Masonic membership in Kansas and solicitation is made through all Kansas lodges and directly to Masons. Each year contributions are received from a substantial number of persons and generally in small amounts, \$100 or less.

The Foundation also actively solicits contributions by suggesting that Masons make bequests to the Foundation through their will or trust. Over many years this solicitation has been successful and has allowed the Foundation to build a permanent fund which, in turn, has allowed the creation of ongoing charitable activity at significant levels.

Contributions received by bequest are unusual because bequests are not received every year; some bequests are very large; the Foundation does not necessarily know that a bequest has been made; and the Foundation cannot predict when or if a bequest will be received.

Bequests have not been received from related parties or from substantial contributors (as measured before the bequest is received) or from control persons. This circumstance should continue in the future.

A single large contribution can adversely affect the public support test under IRC 509(a) (1). An organization is allowed to exclude unusual contributions from its public support test under IRC 509(a) (1).

The following shall be considered unusual contributions to be excluded from the public support test:
