SHENANDOAH VALLEY MEDICAL SYSTEM, INC. (SVMS) IS A FEDERALLY QUALIFIED HEALTH CENTER PROVIDING OUTPATIENT AND INPATIENT HEALTH CARE SERVICES WITH THE GOAL OF IMPROVING HEALTH AND ACCESS TO HEALTH CARE. THERE ARE 50 CLINICIANS REPRESENTING DISCIPLINES OF OB/GYN, MIDWIFERY, FAMILY PRACTICE, INTERNAL MEDICINE, PEDIATRICS, ORAL HEALTH, AND BEHAVIORAL HEALTH. SVMS PROVIDES HEALTH CARE SERVICES TO APPROXIMATELY 31,000 RESIDENTS OF BERKELEY, JEFFERSON, AND MORGAN COUNTIES IN WEST VIRGINIA AND TO MIGRANT FARM WORKERS IN NORTH WESTERN VIRGINIA. APPROXIMATELY 70% OF THE CONSUMERS OF SVMS SERVICES ARE BELOW 200% OF THE POVERTY LEVEL. ALL OF THESE SERVICES ARE PROVIDED REGARDLESS OF ABILITY TO PAY, TO PROMOTE HEALTH AND WELFARE IN THE COMMUNITY. FOR THE FISCAL YEAR ENDED MARCH 31, 2012, SVMS PROVIDED 142,879 MEDICAL SERVICES TO 32,647 PATIENTS. 53% OF THE PATIENTS WERE BELOW THE 100% POVERTY LEVEL. 33% WERE COVERED BY MEDICAID, 22% HAD NO HEALTH INSURANCE.
