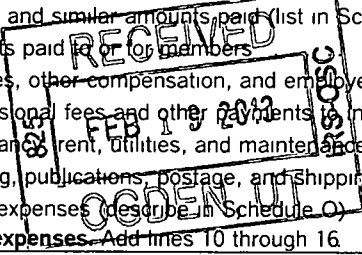

This year our scholarship and grant committee reviewed 100 applications and made 25 awards, totaling \$3,000. Over the past 30 years, MLK365 has given out 1,100 grants totaling of \$118,000.
