Early Childhood Education - YWCA early childhood programs ensure
children enter school ready to learn and succeed. YWCA operates three
child development centers. Children learn and develop in a literacy-
rich environment while their parents seek jobs and education for greater
financial self-sufficiency. 761 children were served; 236 were
homeless; 100% of 4-year olds were assessed as Ready for School (by
Fort Worth ISD at Rosie K. Mauk Center). YWCA offers quality
improvement services to six community based child development centers
in low-income areas of Tarrant County. Centers participate in year-
long mentoring to improve the child care environment, teacher skills

Residential Services - YWCA houses women, aged 18 and older, who are
experiencing extreme poverty. Domestic violence, substance abuse,
physical and mental disability, and foster care history are just a few
of the challenges women at the YWCA must overcome. Participants receive
a safe and secure place to live within a community of women committed
to living and working together and supporting one another to achieve
their goals. Residents engage in case management, secure employment and
plan for the future. In 2011, 117 women were served. 82% of program
graduates increased in income and 11% achieved a GED or high school
diploma during the program.

Racial Disparities - YWCA addresses identified racial disparities in
the health, education and income of people of color in our communities.
YWCA staff completed three "Connecting the Dots on Racial Disparities"

community leaders to explore options for addressing racial disparities
in a tangible way. Also, the reports influenced YWCA strategic
planning, resulting in program enhancements that specifically address
identified racial disparities in Fort Worth and Tarrant County. The
