Conservation Interns 3-12 month internship opportunities for individuals 18 years of age and older, primarily hosted by government agencies on public lands. Internships cover a wide range of areas including scientific research, wildlife studies, habitat restoration and visitor interpretive services. Approximately 1,560 interns were in the field during fiscal year 2012.

Conservation Corps Teams Teams of interns spend 3-10 months devoted to critical environmental issues such as wildfire management and education, trail restoration and maintenance, invasive species eradication, desert restoration and environmental education in public schools. Approximately 42 teams comprised of 513 members were active in fiscal year 2012.

Community Crews Locally based programs for students aged 15-19. In fiscal year 2012, SCA fielded 87 teams in 14 cities with approximately 895 members.
