the strengths and legal benefits of being one incorporated non-profit organization,
but chapters select projects according to interests of local members, elect their own
officers, and manage their own finances. The Society office in Sacramento handles
common administrative work and is the center point for statewide programs. Overall,
33 chapters contribute more than 90,000 volunteer hours each year.

The Education Program provides botanical learning experiences for students in all ranges of age and experience. CNPS hosted the 2012 Conservation Conference in January. It was attended by over one thousand people over the five days of workshops, conference sessions, and public day events. There were 15 workshops, 230 speakers, 4 plenary sessions, and 37 public day presenters addressing a wide range of plant conservation related subject matter. Hundreds of volunteers were engaged in the process. In addition to the conference workshops, the program held four additional workshops with 73 participants. Workshop instructors focus on teaching job skills for surveying rare plants, wetland plants, and vegetation.
