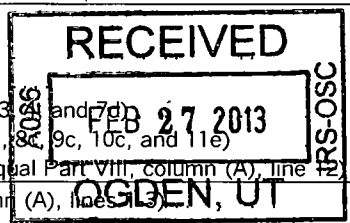

A COMPENSATION COMMITTEE IS SET UP TO REVIEW OFFICERS CURRENT COMPENSATION AND THEN IS COMPARED TO EQUAL POSITIONS AT COMPANIES OF SIMILAR SIZE AND INDUSTRY. CONSDERATION IS ALSO GIVEN REGARDING THE OFFICERS PERFORMANCE AS WELL AS THEIR IMPACT ON THE OPERATIONS AND SUCCESS OF THE ORGANIZATION. RECOMMENDATIONS ARE MADE TO THE GOVERNING BOARD WHO THEN DETERMINES ANY CHANGES IN COMPENSATION.
