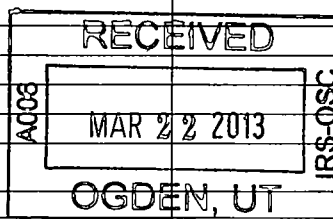

An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audits provide a reasonable basis for our opinion.

In our opinion, the financial statements referred to above, present fairly, in all material respects, the financial position of the Iris and B. Gerald Cantor Foundation as of April 30, 2012 and 2011, and the changes in its net assets and its cash flows for the years then ended, in conformity with accounting principles generally accepted in the United States of America.

Note 1—Organization

The Iris and B. Gerald Cantor Foundation (Foundation) is a private, non-operating foundation incorporated in the State of Delaware in 1967. The Foundation was established to promote and encourage the recognition and appreciation of excellence in the arts, to enhance cultural life internationally through the support of art exhibitions, scholarships, and the endowment of galleries at major museums, and to support bio-medical research.

Note 2—Summary of Significant Accounting Policies

Financial Statement Presentation—The financial statements are prepared on the accrual basis of accounting. The Foundation recognizes contributions, including unconditional promises to give, as revenue in the period received. Contributions and net assets are classified on the existence or absence of donor-imposed restrictions. The net assets of the Foundation and changes therein are classified and reported as follows:

Unrestricted net assets—Net assets that are not subject to donor-imposed stipulations and that may be expendable for any purpose in performing the primary objectives of the Foundation. Unrestricted net assets include amounts available to be used at the discretion of the Board of Directors in the Foundation's programs and operations and those resources invested in equipment. All donations are considered available for unrestricted use unless specifically restricted by the donor.

Temporarily restricted net assets—Net assets subject to donor-imposed stipulations that may or will be met either by actions of the Foundation and/or passage of time. As the restrictions are satisfied, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the accompanying financial statements as net assets released from restrictions.

Permanently restricted net assets—Net assets that are restricted by the donors for investment in perpetuity. The investment income generated from these funds is available for general support of the Foundation's programs and operations.

There were no temporarily or permanently restricted net assets or contributions at April 30, 2012 and 2011.

Income Taxes—The Foundation was incorporated in the state of Delaware as a tax-exempt, private non-operating foundation. Therefore, it is exempt from federal and state income taxes. The Foundation is subject to a 2% federal excise tax on net investment income (reduced to 1% if certain charitable distribution criteria are met). For the years ended April 30, 2012 and 2011, the Foundation's excise tax rate was 2% and 2%, respectively. Accounting standards require an organization to evaluate its tax positions and provide for a liability for any positions that would not be considered '*more likely than not*' to be upheld under a tax authority examination. Management has evaluated its tax positions and has concluded that a provision for a tax liability is

not necessary at April 30, 2012 and 2011. Generally, the Foundation's information returns remain open for examination three years from the date of filing.

Use of Estimates—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements. Actual results could differ from those estimates.

Cash and Cash Equivalents—The Foundation considers all highly liquid investment instruments with a maturity of three months or less at time of issuance and money market accounts to be cash equivalents.

Investments—Investments of the Foundation are stated at fair value. Investments are held by an independent asset custodian or mutual fund company, and all equity investments are managed by professional investment managers. All investment gains and losses and investment income are included in the statement of activities and considered to be unrestricted.

Concentrations of Credit Risk—Financial instruments which potentially subject the Foundation to concentrations of credit risk consist of cash and cash equivalents, receivables and investments. The Foundation places portions of its cash and cash equivalents with high-credit quality financial institutions where the funds are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per institution. In the normal course of operations, such cash balances may exceed the FDIC insurance limits. The Foundation places the remainder of its cash and cash equivalents balances in a money market fund sponsored by a large fund company, these funds are secured by the underlying assets of the fund and have no insurance coverage. Receivables consist of amounts due from investment-related transactions with traditional counterparties. The Foundation's investments are supervised by the Foundation's Chairperson, who, in consultation with professional investment advisors, determines the investment mix of the investment portfolio. Management of the Foundation has assessed the credit risk associated with its financial instruments held at April 30, 2012 and 2011 and has determined that an allowance for potential losses due to credit risk is not necessary.

Art Collection—The Foundation has capitalized its art collection since its inception. The collection consists of sculptures donated to, and purchased by, the Foundation. The art collection is stated at its estimated fair market value as determined by their current insurance values based on periodic formal appraisals. Gains and losses arising due to changes in fair values of the art collection are reflected in the statements of activities. See Contingency footnote.

Property—Property is stated at cost when purchased, or at estimated fair market value at the date of bequest or gift. Depreciation is provided using the straight-line method over the estimated useful life of the related asset, ranging from five to seven years. Individual property items valued at less than \$500 are expensed when purchased or donated.

Note 2—Summary of Significant Accounting Policies—Continued

Contributions Payable—Contributions payable represent the present value of all grants including donated artworks that have been authorized prior to year-end but remain unpaid. The contribution payable is reduced at the time of delivery and formal transfer of the title of the artwork to the donee museum or cash payment.

Donated Services—Donated services are reflected in the statement of activities at their fair market value.

Functional Allocation of Expenses—The costs of providing the various programs and other activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated between the program services and management and general expenses.

Note 6—Charitable Donations and Dispositions of Artwork

During the year ended April 30, 2012, the Foundation donated three pieces of its collection with a fair value of \$20,325 to a museum. During the year ended April 30, 2011, the Foundation sold two pieces of its art collection for \$3,199,980 and donated one piece of its collection with a fair market value of \$300,000 to a museum. Portions of the art collection continue to be available for gifts to museums and sales to third parties.

Note 7—Lease Commitments

The Foundation conducts its operations from one leased facility. As of April 30, 2012, future minimum annual rental commitments for this lease consist of \$19,360 for the year ending April 30, 2013. Rent expense related to the operating lease for the years ended April 30, 2012 and 2011 was \$32,158 and \$30,619, respectively.

Note 8—Related Party Transactions

The Foundation receives most of its contributions from related parties including cash contributions, payroll and related benefits; such amounts received during the years ended April 30, 2012 and 2011 consisted of in-kind payroll and totaled \$186,208 and \$180,921, respectively. The Foundation received payroll contributions from Amethyst, LLC, a related party due to a common participating member.

Note 9—Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy is categorized into three levels based on the inputs as follows:

Level 1—Quoted market prices in active markets for identical assets or liabilities. Level 1 assets include equity securities and mutual funds valued at the closing price reported on the active market on which the individual securities are traded.

Level 2—Observable market-based inputs, either directly or indirectly, but are other than quoted prices in actively traded markets. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and other observable inputs that can be corroborated by observable market data.

Level 3—Unobservable inputs that are supported by little or no market activity which are significant to the fair value of the asset or liability. Unobservable inputs reflect the best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the determination for which category within the fair value hierarchy is appropriate is based on the lowest level input that is significant to the fair value measurement in its entirety.

Note 10—Contingency

In March 2010, a restitution claim was filed in a German court relating to one sculpture in the Foundation's art collection, carried in the statement of financial position at \$1,000,000. The Foundation is working with a third party to resolve the ownership of the sculpture. The ultimate resolution of the claim is being delayed by the lack of a designated person representing the claimant, and the legal process required to resolve the title. Due to the early stage of the resolution process, no adjustment to the carrying value has been made at April 30, 2012.

Note 11—Subsequent Events

Management evaluated all activity of the Foundation through January 28, 2013 and concluded that no material subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
