In FY 2011 PCs for People collected almost 6,000 computers and laptops. Over the course of the year these PCs were refurbished and distributed to low income families. A total of 2,733 PCs were distributed. PCs for People also supports the computers distributed with a 90 day warranty and does discounted repairs after the warranty period. Repairs are \$25 and any parts needed are free. In FY 2011 over 1,200 repairs were completed at an average cost of \$20 per repair.

In FY 2011 PCs for People finished a project to deliver 1,000 computers to rural MN cities. During the fiscal year 400 of the 1,000 computers were distributed to 11 different cities across the state. Also, a mobile refurbish project was started that will distribute approximately 750 PCs to 10 different rural MN cities. 5 of the 10 cities were completed and and 387 computers were distributed by the end of the fiscal year.
