Community Programs-The Junior League of Columbia gathers information related to the needs and resources of the community and uses the information to plan and support various community programs and partnerships which focus on improving the health of children. Programs such as Done in a Day, Kids in the Kitchen, Family Connection, Healthy Start, Spring into Reading, and the Healthy Kids Expo cumulatively hosted 40 different events providing over 700 volunteer opportunities to our League members. Our community programs partnered with 22 nonprofit organizations and 8 elementary schools and reached over 5000 children and their families during this year. Community Assistance Funds distributed \$10,000 to twelve community nonprofit organizations to help meet short-term critical needs.

Volunteer Training Leadership-The Junior League of Columbia provides opportunities to learn about relevant issues and to develop philanthropically, professionally and personally through annual training programs. All programs are available to the 1500 League members and select programs are available to area nonprofit and government partners.
