The Barbara Lawrence Student Paper Award is given to a student(s) who presents a paper at the annual meeting of the Society of Ethnobiology. The recipient of the award is selected by a committee appointed by the president of the society on the basis of both the written and oral versions of the paper. The Society offered a poster award of \$300 for the 2010 annual conference. The Society added two new awards for 2011, the Distinguished Ethnobiologist Award and the Undergraduate Ethnobiologist Award

The Society of Ethnobiology received a two-year (2007-2008) grant for \$10,000 from the Christensen Fund to facilitate participation on indigenous scholars at our annual Society of Ethnobiology Conference.
