Oakland Metro Operahouse. The Oakland Metro Operahouse presents quality productions and performances from artists of all disciplines and genres including classical, spoken word, dance, theater, live music, circus, lucha libre, cabaret and more. Open 3-5 nights a week, in FY 2011-2012 the Operahouse reached an audience of almost 65,000 guests. Patrons were delighted with our productions of The Cheshire Rock Opera, Squeezebox Revolution Accordion Festival, and live music performances by Subhumans, Resistant Culture, Animals As Leaders and many others. The Operahouse also continued to produce it's critically acclaimed, monthly theater events 'Hoodslam' (named the Best Theatrical Performance by the SF Bay Guardian), and 'Tourettes without Regrets', "what Tourettes brings is the deepest concentration of raw talent you're likely to see in the Bay Area" -KQED. Though the Operahouse features some of the most sought after performers in the world, we continue to subsidize and co-produce performances by local non-profit arts organizations struggling to find accessible spaces. In FY 2011-2012, the Operahouse featured shows by New Style Motherload, Bay Area Girls Rock Camp, Bay Area Classical Harmonies, 1 2 3 4 Go! Records, and more. Our fourth year in our new theater has been filled with excitement and challenges, and we are pleased to have created a state of the art performing arts center to benefit our city and local arts community
